



## 2022 STATE OF ORIGIN PLAYER SELECTION POLICY MASTERS DIVISIONS

### 1. Preamble

- 1.1. The purpose of this policy is to ensure a fair and equitable process is undertaken for the selection of the Queensland State of Origin teams.
- 1.2. The policy will cover the Master's Divisions.

### 2. Eligibility Requirements

- 2.1. Players who wish to play in the 2022 State of Origin series must satisfy the eligibility requirements which include:
  - 2.1.1. A player must meet player eligibility to play in State of Origin as outlined in SOO Conditions of Entry, and
  - 2.1.2. A player must be age eligible at or before the 31 December in the year of the SOO (ie 2022). For example, a player must be 45 or over to play over 45s division.

### 3. Selection Policy

- 3.1. Players who wish to be considered for State of Origin selection shall be required to compete and be assessed in at least ***one*** of the following, noting that the Queensland State Cup event is the ***mandatory*** \* event for selection purposes and athletes are required to be at this forum. The other events are considered secondary events for TID purposes.
  - Queensland State Cup\*
  - National Touch League
- 3.2. Players who are unavailable to attend a TID or State of Origin selection event may submit a letter of dispensation in writing to the QTF High Performance & Pathways Manager for approval to still be considered.



- 3.3. The Selection Policy and its processes shall be overseen by the High Performance & Pathways Manager and QTF High Performance Panel.
- 3.4. Players who make themselves available for State of Origin selection may be selected in any team they are eligible for as determined by the QTF High Performance Panel.
- 3.5. Where a player has been selected in a State of Origin team and subsequently withdraws from that team with a valid excuse, such player shall be deemed ineligible for selection in any other State of Origin team for that series.
- 3.6. Where a player has been selected in a State of Origin team and subsequently withdraws from that team without a valid excuse, such player shall be deemed ineligible for selection in any other State of Origin team for that series and, shall show cause why they should be considered for any further SOO series.
- 3.7. In accordance with the Head Coach Selection Policy personnel appointed to State of Origin coaching or management positions shall be ineligible to be selected as a player in any SOO team, unless otherwise approved by QTF High Performance Panel.

#### **4. Selection Process**

- 4.1. The selection / TID process shall be undertaken by the Head Coach and his duly appointed Assistant Coach in each of the relevant divisions. The QTF High Performance Panel will oversee the process and be a part of all deliberations in all divisions. (Note: High Performance outcomes shall be the priority in all selection deliberations and final decisions)
- 4.2. Selections will take into consideration the criteria provided by the Head Coach of the relevant division.
- 4.3. The selection process in Masters Divisions shall be conducted via an appropriate TID process.





- 4.4. All Head Coaches and relevant selectors shall document their justifications for every player they consider suitable for any SOO team. Such justifications will assist in the formation of teams.
- 4.5. Masters Team selection will occur in the following order:
  - 4.5.1 Men's 30s/ Women's 27s
  - 4.5.2 Men's 35s/ Women's 35s
  - 4.5.3 Senior Mixed
  - 4.5.4 Men's 40s/ Women's 40s
  - 4.5.5 Men's 45s/Women's 45s\* Invitational Team
  - 4.5.6 Men's 50s
  - 4.5.7 Men's 55s
  - 4.5.8 Men's 60s\* Invitational Team
- 4.6. Final TID for the State of Origin teams shall conclude at the completion of the NTL competitions and a squad of 24 players will be named in each division.
- 4.7. The relevant SOO HP Advisory Panel member will coordinate selection meetings with the Head Coaches in the order listed in clause 4.5. Players not selected in one division may then be selected in another division, subject to the player's eligibility and in accordance with High Performance program outcomes.
- 4.8. In rare circumstances, players maybe selected into a lower age division if considered appropriate and in accordance with High Performance program outcomes. The final decision on this shall rest with the High Performance & Pathways Manager .
- 4.9. Twenty-four (24) players shall be invited to attend the final team selection camp(s). Notice will be provided of selection camps. *(Note - players shall be required to confirm their acceptance of the invitation to attend the final camp within 7 days of receiving notice)*
- 4.10. At the conclusion, of the relevant camp, Head Coaches shall submit a team list of 14 (fourteen) players and the remaining 10 squad





members will form the shadow group. The High Performance & Pathways Manager shall then seek ratification from QTF Board.

- 4.11. All Queensland State of Origin teams shall be announced via the Qld Touch Football website when all teams are finalized and until that time, strict confidentiality applies to all involved in the process.
- 4.12. Upon announcement of the teams all selected players shall, within the communicated timeframe, be required to confirm their availability to serve as final confirmation of selection.
- 4.13. A panel consisting of the High Performance & Pathways Manager, a SOO HP Advisory Panel member, and other nominee as determined by QTF, shall be established to facilitate and manage all selection disputes and or dispensation requests.

## 5. Replacement of Players

- 5.1 Should a player withdraw from a SOO team or squad; the replacement method shall follow the process below.
  - 5.1.1 The Head Coach contacts the HP & P Manager and notifies them of the withdrawal including relevant reasons. *(Note – Players may be asked to provide documentary evidence of the reason of withdrawal).*
  - 5.1.2 The Head Coach selects a replacement player from the shadow list *(Note - All replacements must come from the shadow list first and additional players may be considered only after this list is exhausted.)*
