



2025 QUEENSLAND STATE OF ORIGIN TERMS AND CONDITIONS

Please read the following Queensland Touch Football (QTF) terms and conditions carefully and do not proceed with your acceptance unless you agree to these terms and conditions. By proceeding and accepting your position in the QLD State of Origin Squad, you are agreeing to these terms and conditions.

QLD STATE OF ORIGIN SQUAD ACCEPTANCE & PAYMENT

Players must accept their position at the 2025 State of Origin Squad and pay **\$110 levy** via MySideline by **Friday 27 December 2024**. If the player fails to complete the acceptance and pay levy prior to this date, their position will be forfeited. This link will be made available to you via e-mail.

SOO SELECTION CAMP CANCELLATION & REFUNDS

Should you as the participant be required to cancel or withdraw your acceptance, the following shall apply:

- Twenty-One (21) days or more prior to the start date – 50% Refund.
Less than Twenty One (21 days) prior to the start date – NO REFUND.
- Withdrawal due to injury, medical certificate provided – Refund minus admin fee of \$10.00, can be accepted up until 24 hours prior to camp commencement. The email sent date, and time will be deemed as the notification date and time.

All cancellation requests and refunds requests must be received in writing to QLDSOO@qldtouch.com.au within the timeframes as outlined above.

Participant Failure to Attend: QTF accepts no liability for a person's failure to attend a camp at the designated time and location for any reason whatsoever. **No refund will be available.**

The QLD State of Origin Squad levy will include costs associated with Selections Camps including venue hire, medical, strapping, meals, and training shirt.

In the event of an adverse weather event, QTF will endeavour to conduct the camp in a revised format either indoors, undercover or potentially vary the start or finish time.

Where the scheduled camp cannot be conducted at the proposed date, time and venue due to a Force Majeure Event, QTF is relieved of that obligation. QTF has no obligation to refund any fees or reschedule the camp.

QLD STATE OF ORIGIN TEAM ACCEPTANCE & PAYMENT

The 2025 State of Origin teams will be announced on Wednesday 12 March 2025 following The Championships (NTLs).

Players must accept their position at the 2025 State of Origin Team and pay a **\$200.00** deposit via MySideline by **Friday 4 April 2025**. If the player fails to complete the acceptance and pay levy prior to this date, their position will be forfeited. This link will be made available to you via e-mail.

Payment is non-refundable except in the case of injury supported by a medical certificate as outlined below.

If this payment is not made by outlined date, you will forfeit your place in the 2025 QLD State of Origin team.

QLD STATE OF ORIGIN TEAM LEVY FINAL INVOICE

The final player levy amount is \$800 per player including the acceptance deposit...

Final payment of the SOO Levy invoice is required to be paid by **COB 5pm Friday 23 May 2025**. An invoice will be sent to all individuals for payment.

If payment is not made by the outlined date, you will forfeit your place in the 2025 QLD State of Origin team.

CANCELLATIONS & REFUNDS

Should you as the participant cancel or withdraw your acceptance in writing, the following shall apply:

- Six (6) weeks or more prior (Fri 9 May 2025) to the start date – Full Refund, **less \$200.00 non-refundable deposit**
- Twenty-One (21) days or more (Fri 30 May 2025) but less than 6 weeks prior to the start date – 50% Refund, **less \$200 non-refundable deposit**
- Less than Twenty One (21) days prior to the start date – NO REFUND.

Exception: If the withdrawal / cancellation is due to an injury which is supported by a medical certificate then all fees will be refunded minus a \$20.00 administration fee.

All cancellation requests and refund requests must be received in writing to QLDSOO@qldtouch.com.au within the timeframes as outlined above. The email sent date and time will be deemed the notification date and time.

Participant Failure to Attend: QTF accepts no liability for a person's failure to attend the event at the designated time and location for any reason whatsoever. **No refund will be available.**



FORCE MAJEURE EVENT

In the event of a Force Majeure event impacting State of Origin, QTF has no obligation to refund any levies.

For the purposes of these regulations a force majeure event includes but is not limited to any or all of the following:

- Acts of God including flood, drought, earthquake, storm, cyclone, fire, explosion, epidemic; or
- War or Act of Terrorism; or
- Riot or civil disturbances; or
- Permanent injunction of any duly constituted court of competent jurisdiction; or
- Any fact, circumstance, matter or thing beyond the reasonable control of QTF i.e., global pandemic or lock down.
